Center For Public Integrity - Washington-Baltimore News Guild Memorandum of Agreement

In accordance with Article XIV, Section 6 of their collective bargaining agreement, the parties agree to modify their collective bargaining agreement in the following ways:

- 1. Effective April 1, 2021 all covered employees making less than \$100,000 a year will receive a 3.25% salary increase and all covered employees making greater than \$100,000 a year will receive a 2% salary increase.
- 2. Effective April 1, 2022 all covered employees making less than \$100,000 a year will receive a 3.25% salary increase and all covered employees making greater than \$100,000 a year will receive a 2% salary increase.
- 3. Effective April 1, 2021 the minimum full-time annual salary for employees in Group I will be \$50,000 a year.
- 4. Effective April 1, 2021, the minimum full-time annual salary for employees in Group II will be \$70,000 a year.
